> A report on University Matters for the 2018 academic year by Professor Dr. Bundhit Eua-arporn, President of Chulalongkorn University, Thursday October 3, 2019 (morning session) at the Main Auditorium, Chulalongkorn University

Your Royal Highness,

With your kind and gracious permission may I take this opportunity to present a report on Chulalongkorn University's performance matters for the 2018 academic year classified according to the 4 missions – producing graduates, research, development and innovation, rendering of academic services and preserving the arts and culture.

Chulalongkorn University's Performance in terms of Producing Graduates

The 2018 academic year saw a total of 10,160 new enrolments, 6,498 of whom are undergraduates and 3,662 at the graduate level. The total number of students is 37,018 of which 25,382 (68.6%) are undergraduates and 11,637 (31.4%) are graduates. As a whole the total number of this year's enrolment is 28 students less than last year.

At present the University offers a total of 442 degree programs, of which 98 programs are international or English programs. There are altogether 73 undergraduate level programs and 369 graduate programs and 211 of them are Master's Degree programs.

The University has carried out its task of curricula and education development for example the development of the Transdisciplinary Integrated Curriculum, implementing Active Learning and Lifelong Education, offering a Liberal Arts Program as well as a Bachelor of Science in Integrated Innovations (International Program), emphasizing the integration of subjects in the Liberal Arts and Sciences to ensure that its graduates are endowed with the capabilities of the 21st century. New technological structures are now in place to support new forms of learning, promoting self-learning methods so that students are filled with the desire to pursue knowledge themselves. They should be ready to embrace the current changes they face today and to be able to foresee the trends of the future.

In terms of physical spaces and creating an ambiance conducive to learning, the University emphasizes the use of space for students to be able to learn together in groups by providing an information technology system and internet structure that makes it possible to access information in all areas.

In the past year there has been an exchange of faculty and researchers with as many as 935 outbound and 68 inbound exchanges. As many as 982 students have been sent abroad for studies and presentations while on the other hand 1,325 foreign students have come to Chulalongkorn University for study/research/practical training. There is now an agency to support innovations as an incubator that provides students with the opportunity to develop their potentials in the form of startups.

Specifically, in terms of scholarship support and assistance, provisions have been made for needy students who can avail of 1,715 welfare scholarships worth 49.4 million baht and about 2.3 million baht in scholarships for students who have brought fame to the university and 462 have applied for student loans worth a total of 23.5 million baht. At the graduate level, 14 types of scholarships are available for students to respond to their needs in terms of education, research, student presentations and theses writing. Moreover, we take pride in the fact that our students have brought fame to the University and are exemplary in their efforts earning as many as 673 awards for their various endeavors

Performance in research, development and innovation

The University targets the creation of excellence in academic and research matters and aims to create knowledge, integration and creative innovation that can be further developed and targeted to benefit a wider circle.

In the past year the University has had as many as 1,989 research projects, both new and continuing projects, that received research funding totaling an estimate of 2 billion baht. We have introduced various driving strategies to promote research with a clearer direction and created supporting systems such as increasing the number of research groups working as teams divided into three levels: 41 groups of Special Task Force for Activating Research : STAR, 148 units for Research Units : RU and 40 Centers of Excellence : CE – a total of 229 units.

In terms of implementing the projects aimed at strengthening the university as it moves into its second century for research a large scale Frontier Research project aims at promoting allies in research strategies for international research through the creation of the International Research Forum to enable proactive alliances with leading universities in the world by jointly producing doctoral degree graduates. This has been launched this year with scholarships for doctoral students as well as postdoctoral research funding. Support has also been rendered to some interesting projects such as the ChulaAri which is related to the aging society, a Robotics project, a cancer project and a project to further develop herbal products.

This year our personnel both lecturers and researchers have been recipients of a total number of 109 awards, 36 at the international level and 73 at the national level. Of these 37 awarded research projects, 3 fall under the individual category and 34 for research works. At the national level we have earned as many as 25 awards, 15 for individuals and 10 for research works.

Performance in Academic Services

The University continues to provide academic services deriving from its areas of expertise that could benefit society. In the past year there have been a total of 3,542 projects with 126,145 situations serving as many as 2.7 individuals or agencies.

The University is promoting the concept that would benefit the society in terms of lifelong education and preparation for entering into an aging society. It has developed the CHULA MOOC project which is a form of online learning that provides people from all walks of life to access

various subjects which is a way of extending education to society. The project has been well received the most popular being the SPACE project offered by the Faculty of Commerce and Accountancy which is an online program aimed at offering knwledge on business practices.

In the past year the University has disseminated information, academic matters and presented topics that are the focus of inquiry or interest or pertaining to issues that have direct impact on society via online media as well as round table discussions on relevant topics of interest such as "The Rabies Crisis", "Endangered Animals" "Chula Offers Solutions to the PM 2.5 Particulate Matters" etc.

We have also created the "Chulalongkorn University Innovation Hub" which aims to promote the creation of skills needed for innovation entrepreneurs which provides opportunities for creating inspirations, continuing research works, supporting student developments and providing opportunities for the general public.

Performance on Conservation of the Arts and Culture

The University considers the conservation of arts and culture as a serious matter and has continuously upheld the task of conserving our cultural and artistic heritage by promoting the creation of knowledge needed for the development of academic projects related to the arts and culture, religion, customs and traditions with altogether 585 or more activities held throughout the year attracting more than 130,000 interested persons. Some of the interesting activities include musical and dance performances, the *Wai Khru* ceremony paying respects to venerable Thai classical music teachers, classical music concerts performed by the Symphony Orchestgra of Chulalongkorn University featuring the university's own songs in a new arrangement performed by faculty members and alumni who are now well known musicians, the sixth art exhibition of the works by famous artists who are administrators and personnel of this University and more than 20 western music recitals in collaboration with national and international agencies.

This year we have had the opportunity to organize continuing activities in celebration of His Majesty the King's coronation such as a special lecture for the General Education Short Program (CUVIP Talk) on the subject of the royal coronation ceremony by Distinguished Professor Tongthong Chandransu, a tree planting activity by members of the Chula community in honor of His Majesty the King on the occasion of his coronation in 2019 and a concert to commemorate this memorable occasion featuring both Thai and western musical performances.

We have also compiled several books for publication as a way to disseminate knowledge to those who are interested in various subjects such as "Buddhist Dharma words often misunderstood", the fourth volume cataloguing art works found in all museums and galleries in Chulalongkorn (published in English) and the Tipataka Studies Project which provides a compilation of online learning media on "2,600 Years in Continuing the Pali Tipataka.

The University has activities that promote exchange of cultural knowledge such as the ASEAN art integration project which marks the collaboration between universities in the AUN-AYCF network of Thailand or the hosting of the World Hindi Language Day.

We are proud too that this year the "Chulalongkorn Centernery Park" won an award for large scale completed projects from the World Landscape Architecture Awards 2019 (WLA). The park is a model of metropolitan parks that showcases the most effective forms of management of space and water resources in an environmentally friendly manner.

With regard to seeing to it that attention is given to ensuring a sustainable environment the University has continued to employ its zero waste program to promote and instill the concept so that it becomes a vital way of life of our staff and students and expand further to dissemination and the results have been so far satisfactory. During the past year Chulalongkorn has been ranked in the UI GreenMetric World University Ranking for Green Universities for 2018 at number 95 in the world and number 3 in Thailand. It has scored first in Thailand in 4 indicators i.e. Energy Management, garbage management, transportation and education and research.

In the 2018 academic year there are a total of 9,429 graduates comprising 481 doctorate degree, a total of 2,835 master's degree, 52 degree certificate level, higher diplomas, 247 bachelor's degree level 5,625 and 189 one associate degree level.

Commendation on the Occasion for recipients of doctorate degrees (*honoris causa*),

> Commendation on the Occasion when Professor Jintakorn Kuvattanasuchati is appointed Professor Emeritus in the Faculty of Dentistry

The Chulalongkorn University Council, at its 828th meeting held on June 27th, 2019, recognized that Professor Jintakorn Kuvattanasuchati is acknowledged as an academic whose knowledge and expertise in microbiology is exemplary. He has devoted himself diligently to the tasks of teaching and academic research and is widely accepted at both the national and international level. Therefore, he is deserving of this honor that ensures he will forever be a role model to all.

Professor Jintakorn Kuvatanasuchat received his Bachelor of Dentistry degree from Chulalongkorn University in 1974 and entered the civil service as a lecturer in the Department of Microbiology, Faculty of Dentistry, Chulalongkorn University that same year. He furthered his education at the same institution and received his Master's of Pharmacuetical Studies (Microbiology) in 1981, then pursued his studies in Oral Microbiology graduating from Mund University in Sweden in 1986. By royal appointment he became a level 10 Professor in 2011. His volume of research includes as many as twenty text books, eight of which are publications in international journals, with two of the textbooks centering on the subject of microbiology and oral cavity disease that serve as a crucial basis in the dental profession.

Aside from imparting his knowledge on microbiology to second, third and fourth year undergraduate students, Professor Jintakorn Kuvattanasuchati has also served as a mentor for third, fourth and fifth year students in their research practicum. He has instilled in his students concepts and values derived from his personal expereince as a dentist for over 38 years constantly reminding them that patients need to be treated in the manner set forth by His late Majesty King Bhumibol's Prince Father, the Prince of Songkhla who prioritized the needs of his patients ensuring that they be treated with empathy and compassion. His students are reminded of the importance of rational thinking to determine the cause and incidence of disease and to perceive how essential microbiology is in the dentistry profession. It should also be stressed that, as a practicing dentist himself, he adhered to the training process of intellectual self-questioning. He has served as a reader assessing the quality of papers submitted to the academic journal of the Faculty of Dentistry, Chulalongkorn University. These efforts continued even after his retirement from government service with academic work for other academic institutions such as Vajira Hospital's Vajira Medical Journal and the Journal of Urban Medicine.

Professor Jintakorn Kuvattanasuchati has pioneered the study of microbiology in relation to dentistry and has published widely on this subject. Even after his retirement his articles have appeared in the PubMed data base. In 1996 he was awarded the distinguished title of National Researcher.

Professor Jintakorn Kuvattanasuchati held the administrative position of Head of the Department of Microbiology at the Faculty of Dentistry, Chulalongkorn University (2001-2005). He has been invited to serve on the screening committee for award applications at Mahidol University. He continues to contribute his time and talents to the Department of Microbiology as a guest lecturer and adviser to those taking Microbiology Practicum courses. Known for his strong determination and devotion he has earned unwavering love and respect from his students. He continues to write and to publish academic works and to contribute his academic expertise for the benefit of his society. For the past twenty years he has volunteered his services to the mobile dental clinic, which is a royal initiative, in the same way that he has done for the mini dental clinic of the Faculty of Dentistry, Chulalongkorn University which gives free basic dental treatment to the poor and needy.

Professor Jintakorn Kuvattanasuchati is a scholar who is endowed with competence, virtues and ethics in the academic and professional areas. He has brought recognition to his Department, Faculty and to the University and Chulalongkorn University Council has thus, unanimously agreed to appoint him Professor Emeritus of the Faculty of Dentistry to honour him in the years to come.

Professor Dr. Kammant Phantumchinda received his Bachelor of Science (second class honors) degree in 1973 and Doctor of Medicine with honors in 1977 from Chulalongkorn University. He later obtained a Master of Science degree in Clinical Epidemiology from McMaster University, Canada in 1985. He entered the civil service at the Department of Internal Medicine, Faculty of Medicine, in 1980, and received certification for his knowledge and expertise as a practitioner in Neurology that same year and a document of certification for knowledge and expertise in internal medicine specializing in Geriatrics Medicine. In 1991 was appointed as Professor by the Medical Council of Thailand.

Professor Dr. Kammant Phantumchinda has distinguished himself being appointed Fellow by numerous foreign institutions such as The Royal College of Physicians (London) (FRCP), The American College of Physicians (FACP), The Royal Australasian College of Physicians (FRACP) and The Philippine College of Physicians (FPCP). He also been awarded Chulalongkorn University's Outstanding Personnel under the category of Best Teacher in 1993, co-awardee for His Majesty the King's Jubilee Research Fund by Chulalongkorn University in 2001 and certificate for outstanding physicians shortlisted by the Thai Medical Council in 2004.

Professor Dr. Kammant Phantumchinda has held important administrative positions, for example, Head of the Department of Internal Medicine, President of the Royal College of Physicians of Thailand, President of the Neurological Society of Thailand and currently serves in other vital positions such as President of the Dementia Association of Thailand and Member of the Medical Council of Thailand, member of the subcommittee of the National List of Essential Medicines for Neurology. Since his retirement from government service he has been invited to be a guest lecturer at the Faculty of Medicine, Chulalongkorn University and King Chulalongkorn's Memorial Hospital at the Thai Red Cross Institute.

In terms of his accomplishments in research, Professor Dr. Kammant Phantumchinda has studied the medicinal characteristics of neurological diseases especially rare cases or those detected for the first time in Thailand. His research has had a profound impact at both the national and international level. His involvement in outstanding research projects has included a research project in collaboration with the World Health Organization on the impact of birth control pills and the

occurrence of strokes, a study on the epidemiology of headaches and dementia which also received publication in an international journal.

Professor Dr. Charat Suwannamala received his Bachelor's Degree in Political Science from Chulalongkorn University in 1976, a Master's Degree in Economics also from Chulalongkorn University in 1981, a Master's Degree in Public Administration (with honors) from the National Institute of Development Administration in 1983 and a Doctorate in Political Science from Northern Illinois University. He has written extensively on matters related to public finance and local finance for target audiences at both the national and international level. Some of his works include: "The Budget System and Management Aiming at Success in the Government Sector", "The Relationship between the State and Modern Day Citizens" (2003), "Basic Knowledge on Public Finance Administration", "Government or Local?: Who Should Provide Public Services?", "Local Thai Innovations and State Sector Finance in Relation to Power Struggles, Betrayals and Recklessness" (2013). He has also worked for the World Bank as an expert on Financial Decentralization and headed numerous research projects such as the project for compiling a 20 year plan for the development of the Bangkok Metropolis (2013-2032) and the New Path for Local Thai Government Institutions project. He initiated the idea of turning networks of Thai political data websites into public information for those interested in gaining in depth information on the subject of Thai politics. He received the award for Outstanding National Researcher in Public Administration from the National Research Council of Thailand in 2011. In terms of government and politics he served as a member of the Committee on Decentralization in the early days and took part in the Thai Constitution Drafting Committee in 2012. As an administrator, Professor Dr. Charat Suwannamala was Dean of the Faculty of Political Science, Chulalongkorn University (2006-2010). He was the proud recipient of the Outstanding National Researcher Award from the National Research Council of Thailand in 2011 in Public Administration. He has good rapport and is able to work well with others whether in administration, research or academic services ensuring that all tasks are carried out smoothly. It is well accepted that by nature he is straightforward, honest and sincere and he is a morally upright person who adheres to the principles of good governance in his work. When he encounters anything does not appear to be right or appropriate he will immediately make sure that he raises objections or admonishes the perpetrator to ensure that similar mistakes and errors do not arise. He is clear that any kind of project that relies on state funding must adhere strictly to the principles of good governance and that its execution should yield the greatest benefits possible. He insists on righteous deeds alongside compassion and his thoughts and decisions are honest and staightforward, hence he has become a role model in his professional endeavors that others should emulate.

He has also shown a willingness to help out with any tasks whether academic or otherwise requested of him by the Faculty of Political Science.

The Chulalongkorn University Council, at its 828th meeting held on June 27th, 2019, recognized that Professor Dr. Pattarapan Prassassarakich is an exemplary academic who is endowed with knowledge and expertise. She is highly qualified in the area of chemical engineering and has devoted her life to being an educator who has also worked extensively on research into polymers and the development of alternative energy from biomass. Her research has been well received at both the national and international levels and it is befitting that she be honored and regarded as an example to all.

Professor Dr. Pattarapan Prassassarakich earned her Bachelor of Science degree from Chulalongkorn University in 1973 and a Master of Science degree in Chemical Engineering from the University of Wisconsin in 1974, followed by a Doctorate of Science in Chemical Engineering from Kansas State University in 1979. That same year she began her career as a lecturer at the Department of Chemical Technology, Faculty of Science, Chulalongkorn University and was tenured as Assistant Professor, Associate Professor and Professor in Chemical Engineering in 1982, 1986 and 1995.

Professor Dr. Pattarapan Prassassarakich is an expert in the teaching of Chemical Engineering Thermodynamics and has authored a textbook on that subject which has been widely used by academics from various institutions and is often cited in subjects dealing with Chemical Engineering and other related fields.

In the research projects she has conducted Professor Dr. Pattarapan Prassassarakich's focus has been on polymers and fuel technology. One important research on polymers concerns the hydrogenation of natural rubber and the graft polymerization of natural rubber that could lead to the development of natural rubber products in the polymer industry in the future. In terms of her research on fuels are the study of biomass processing to liquid fuels and the production of biomass oil through Supercritical Liquefaction of biomasses such as sugarcane, corn and palm oil. Her continuous research on biofuels has led to other vital research such as biodiesel production by way of hydrogenation of raw palm oil and used vegetable oil and the desulpherization of diesel oil through the process of absorption. A total of 113 of her research works have been published in international journals with a widely accepted data base and a number of them have received financial support from such government organizations as the National Science and Technology Development Agency and the Royal Golden Jubilee Ph.D Fund of the National Research Council of Thailand which is a collaboration with Pennsylvania State University in the U.S.A., and the University of Waterloo in Canada (1997-2017). She has been instrumental in producing doctoral graduates in Chemical Technology who ultimately have become highly qualified personnel integral to the work of energy and materials development in Thailand.

Professor Dr. Pattarapan Prassassarakich has held such important administrative positions as Deputy Director of the Petroleum and Petrochemical College (1989-1993) and Head of the Department of Chemical Technology, Faculty of Science (altogether two terms 1996-2000 and 2004-2007). She is currently an adviser for the Association of Polymers of Thailand and has given advice that has served to benefit the development of rubber and polymer technology in Thailand's academic and industrial circles.

After retiring from government service, Professor Dr. Pattarapan Prassassarakich was appointed Honorary Professor of the PTT (Public Company) (2018-2019). She continues her work at the Department of Chemical Technology both in terms of teaching and research and has contributed more to the volume of academic works she has produced.

Professor Dr. Pattarapan Prassassarakich is a scholar who is endowed with competence in academics, research and administration and has performed all tasks while displaying the virtues of great ethics and morality. She has achieved outstanding recognition at the national and international level. Professor Dr. Chonlada Ruengraklikhit obtained a Bachelor of Arts Degree(Honours) from Chulalongkorn University in 1974. She subsequently received a Master's Degree and a Doctoral Degree from the Faculty of Arts in 1976 and 1992 respectively. In 1977, she became a lecturer at the Department of Thai in the Faculty of Arts and was appointed a full Professor, Level 10, in 2012.

Professor Dr. Chonlada Ruengraklikhit is an expert in Thai Literature. Her twenty pieces of work in the form of research, academic papers, books and textbooks present a body of knowledge that covers diverse issues and perspectives on Thai literature of the Sukhothai, Ayutthaya and Ratanakosin Periods, for example, the study of the literary conventions of the early Ayutthaya Period, the works of Sunthorn Phu, Thai prosody, vocabulary and expressions in Thai literature, the relationship between Thai and foreign literature and the relationship between Thai literature and contemporary literary works. She has written a number of manuals for several Thai literary works. These manuals, which have become sources for the study of Thai literature at the university level, are *Critical Reading and Interpretation of the Ong Kan Chaeng Nam, Critical Reading and Interpretation of the Maxims of Phra Ruang, Critical Reading and Interpretation of Nirat Narin* and *Critical Reading and Interpretation of Lilit Phra Lor.*

The academic and research works produced by Professor Dr. Chonlada Rueangraklikhit have been recognized in academic circles. This is evident in her being presented with a number of awards, for example; an Award for a Person with Distinguished Works in the Thai Language from the Chamnong Thongprasert Foundation of Maha Chulalongkorn Rajawitthayalai University, in 2014; a Distinguished User of the Thai Language Award from the Ministry of Culture in 2012; a Promoter of Thai Poetry Award (an Individual Category) from the Sunthorn Phu Institute in 2017; a Respectable Person in the Thai Language Award from the Ministry of Culture in 2017; and a Distinguished Conserver of the Thai Heritage Award in 2019.

Professor Dr. Chonlada Ruengraklikhit's expertise in the Thai language and literature has earned her an appointment to a number of committees and important positions in many working groups at the national level, for instance; an Associate Fellow of the Academy of Arts in the category of the Arts of Literature (Poetry) of the Thai Royal Society; ; editor of an encyclopaedia of modern Thai literature; an academic member of a number of the working groups of the Thai Royal Society, namely, a member

of the Committee for the Promotion and Dissemination of the Thai Language, a member of the Committee for the Compilation of Foreign Vocabulary and Expressions Which Can Be Replaced by Their Thai Counterparts, a member of the Committee for the Compilation of Thai Literary Terms, a member of the Committee for the Explanation of Thai Words for Radio Broadcast, an Ad Hoc specialist at the meetings of the Committee for Compiling Basic Vocabulary in Thai Culture, a judge for the Competition in Thai Language Skills and a judge for selecting distinguished users of the Thai language to be nominated for the Rajabundit Sansern Award. She has also served as an invited lecturer to present supplementary knowledge on Thai literature at the Teachers' Training Project of the Royal Society, an advisor to the National Literature Committee of the Department of Fine Arts, the Ministry of Culture and a Vice Chair of the Working Group on Literature Appreciation for the Ministry of Education.

In terms of learning and teaching, Professor Dr. Chonlada Ruengraklikhit is a teacher who has dedicated herself to the teaching of the Thai language and literature. Professor Dr. Chonlada Ruengraklikhit is a scholar who has contributed greatly to the study of the Thai language and literature for a long time. Her works have been recognised both near and far. The Chulalongkorn University Council has, thus, unanimously agreed to appoint her Professor Emeritus in order to honour her in the years to come.

The Chulalongkorn University Council, at its 828th meeting held on June 28th, 2019, recognisd Professor Dr. Suwanna Satha-anand as a scholar in Chinese, Confucian and Buddhist Philosophy. Her academic works in Buddhist Philosophy, women and Buddhism and Chinese Philosophy have extensively been recognized at the national and international level. It is, thus, deemed appropriate for the University to praise, honour and cherish her as a good example for the years to come.

Professor Dr. Suwanna Satha-anand received a Bachelor of Arts Degree (First Class Honours with a Gold Medal) in 1977 from the Faculty of Arts and was subsequently granted a scholarship to pursue her graduate studies at the University of Hawaii at Manoa. She also received a Joint Doctoral Research Intern Grant from the Culture Learning Institute of the East-West Center in the U.S.A. and completed her Doctoral Degree in 1983. In 1989, she became a lecturer in the Department of Philosophy at the Faculty of Arts and was appointed a full Professor in 2014.

Professor Dr. Suwanna Satha-anand has been distinguished in her teaching career serving as an advisor and a co-advisor to more than thirty graduate students. She has contributed to the development of her students turning them into knowledgeable and capable graduates in keeping with international standards. These graduates have later become high quality lecturers in Philosophy in Thailand's top academic institutions or have pursued their careers as researchers in Philosophy abroad.

In terms of academic matters and research, Professor Dr. Suwanna Satha-anand has produced approximately one hundred works in the form of books, research works, research papers, academic papers, translation works and book editorials. Some of her works that were written in English have been translated into French, Chinese and Korean. Her major research work deals with the translation of a collection of maxims in Confucian Philosophy, the *Lun Yü Doctrine*. In this research work, she wrote an introduction of more than 150 pages, to enable those interested in Chinese Philosophy and researchers in this area to understand Confucian Philosophy in its important fundamental concepts. This translation research is extensively referred to in academic circle and by researchers in philosophy. At present, she is a Senior Research Fellow in Philosophy (2018 -2021) at the Thailand Research Fund (TRF).

Professor Dr. Suwanna Satha-anand has made a great contribution to the Humanities in Thailand. In 2003, she initiated the Humanities Research Forum of the TRF to develop networks of researchers in Humanities, consisting of senior, mid-career and new researchers. The Forum has also been extended to include graduate students to create a national platform for them on which to present their research works and to open up the relationship between Humanities and contemporary society.

In administration, Professor Dr. Suwanna Satha-anand has been Chair of the Department of Philosophy at the Faculty of Arts (1996 -1998), an Associate Dean for Research at the Faculty of Arts (2001 -2013), a Member of the Arts Section of the Anandamahidol Foundation (2001 –the present), President of the Philosophy and Religion Society of Thailand (2006 -2008), a Distinguished Member of the Administrative Committee of the Princess Maha Chakri Sirindhorn Anthropology Centre (2009 - 2013, and for a second term 2017 –the present), a Member of the Academic Policy Committee of Chulalongkorn University (2010 –the present) and Deputy Director of the Humanities Research Forum at the Thailand Research Fund (2014 -2016). At present, she is the Secretary-General of the International Federation of Philosophical Societies, which is the largest network of international philosophical societies in the world.

Since her retirement, Professor Dr. Suwanna Satha-anand has still continued to work in a way that is beneficial to the Department of Philosophy—teaching, being a thesis advisor to graduate students and providing suggestions to faculty members and staff of the Department of Philosophy. Her determination and meticulous care in her work have won her great admiration from her colleagues and love and respect from her students and clerical staff.

It is, therefore, deemed appropriate for the University to praise, honour and cherish her as a good example for the years to come.

Professor Dr. Sirimonporn Suriyawongpaisal obtained a Bachelor of Arts Degree in Japanese from Massey University in New Zealand in 1975; a Master's Degree in Japanese Language and Literature from the University of Auckland in New Zealand in 1977 and a Doctoral Degree in Japanese Literature from Harvard University in the U.S.A., in 1995. She continued her studies with two periods of one-year research in Noh Drama at Waseda University and Hosci University in 1979 and 2002, respectively. In 1977, she became a lecturer in the Department of Eastern Languages at the Faculty of Arts, where she was appointed a full Professor in 2013. Twenty-five out of her sixty-nine academic and research works on the Japanese language and literature published in Japanese, English and Thai have been presented at international conferences or at universities abroad or have been published overseas.

Professor Dr. Sirimonporn Suriyawongpaisal has taught the Japanese language and literature at the Bachelor's, Master's and Doctoral Degree level in both regular and international programmes, inside and outside the Faculty of Arts. She has served as a thesis advisor for graduate students in the Japanese Language and Literature Section, the Literature and Comparative Literature Section as well as in the Japanese Culture and Literature Section. Professor Dr. Sirimonporn Suriyawongpaisal is a trailblazer in research on Noh Drama as well as an initiator of the teaching of Kambun in Thailand. (Kambun is Japanese literature written in Chinesestyle Japanese or in Japanese-style Chinese). She was the first Thai researcher whose work received a Distinguished Research Award from the Chulalongkorn University's Royal Golden Jubilee Fund in 2013. She has been invited to serve as an assessor of many journals at the national level, for example, the *Journal of the Japanese Studies Association in T*hailand and the *Journal of the East Asian Studies Institute.* Her other academic activities have included her being a visiting lecturer in the Project for

Creating Japanese Studies Researchers in the ASEAN Community, which was organized by a Japanese organization; her creation of a research team with American and Japanese researchers with the aim of presenting works at international conferences; her being invited to be an international steering committee member of the Japanese Studies Association of the ASEAN Region (JSA ASEAN), from the time it was founded in 2006 until the present. She has attended an international conference once every two years, where she has been invited to serve as a session chair or a discussant. She was invited to be the core leader of Nishogakusha University's World Organization for Kanbun Studies 21st Century COE Program in Japan, as well as a visiting scholar at the University of California in Los Angeles (UCLA) and at the University of Hawaii in Manoa in the U.S.A.

She completed her studies for a Magister Artium (M.A.) and a Dr. Phil (Ph.D.—Doctor of Philosophy) from Ruprecht-Karls University in Heidelberg in the Federal Republic of Germany in 1980 and 1985 respectively. She started her teaching career in the German Section of the Department of Western Languages in the Faculty of Arts in 1976 and was appointed a full Professor in 2001. Her research works in the German language and literature as well as in German Studies are in the form of books, textbooks, translation works and articles; 164 in total. She has also served as the editor of eighteen books and journals.

As well as teaching students in the German Section of the Western Languages of the Faculty of Arts and in the Faculty of Applied and Fine Arts, the Faculty of Political Science and the Faculty of Science at Chulalongkorn University, Professor Dr. Pornsan Watanangura has been Chair of the Doctoral Degree Programme Drafting Committee of the German Section in the Faculty of Arts at Chulalongkorn University and also the Chair of the Working Committee of the Pedagogical Studies Programme, which is the only programme of its kind in Southeast Asia. She has collaborated with the Goethe Institute— Bangkok-Munich, the Ministry of Education, German specialists and academics from schools and universities in Thailand to write German textbooks for high school students. These textbooks have been used in schools all over the country for more than ten years. She has also produced textbooks on language, phonetics and reading, which have been used at the university level. From 2000 to 2012, she taught German to secondary school students at Klai Kang Won School as part of the Long Distance Learning via Satellite Project. In 2004, her teaching was televised to the public via the Television Station for Long Distance Learning of the Ministry of Education and from 2009 -2016, via the Distance Television of Klai Kang Won School. This is a good example of her public service which has been extensively beneficial to the community and the general public. In 2012, she was invited to teach at the Deutsch als Fremdsprachenphiologie Institute in the University of Heidelberg in the German Federal Republic.

He has devoted himself diligently to the tasks of teaching and academic research and is widely accepted at both the national and international level. Therefore, he is deserving of this honor that ensures he will forever be a role model to all.

Professor Jintakorn Kuvatanasuchat received his Bachelor of Dentistry degree from Chulalongkorn University in 1974 and entered the civil service as a lecturer in the Department of Microbiology, Faculty of Dentistry, Chulalongkorn University that same year. He furthered his education at the same institution and received his Master's of Pharmacuetical Studies (Microbiology) in 1981, then pursued his studies in Oral Microbiology graduating from Mund University in Sweden in 1986. By royal appointment he became a level 10 Professor in 2011. His volume of research includes as many as twenty text books, eight of which are publications in international journals, with two of the textbooks centering on the subject of microbiology and oral cavity disease that serve as a crucial basis in the dental profession.

Aside from imparting his knowledge on microbiology to second, third and fourth year undergraduate students, Professor Jintakorn Kuvatanasuchat has also served as a mentor for third, fourth and fifth year students in their research practicum. He has instilled in his students concepts and values derived from his personal expereince as a dentist for over 38 years constantly reminding them that patients need to be treated in the manner set forth by His late Majesty King Bhumibol's Prince Father, the Prince of Songkhla who prioritized the needs of his patients ensuring that they be treated with empathy and compassion. He entered the civil service at the Department of Internal Medicine, Faculty of Medicine, in 1980, and received certification for his knowledge and expertise as a practitioner in Neurology that same year and a document of certification for knowledge and expertise in internal medicine specializing in Geriatrics Medicine. In 1991 was appointed as Professor by the Medical Council of Thailand.

Professor Dr. Kammant Phantumchinda has distinguished himself being appointed Fellow by numerous foreign institutions such as The Royal College of Physicians (London) (FRCP), The American College of Physicians (FACP), The Royal Australasian College of Physicians (FRACP) and The Philippine College of Physicians (FPCP). That same year she began her career as a lecturer at the Department of Chemical Technology, Faculty of Science, Chulalongkorn University and was tenured as Assistant Professor, Associate Professor and Professor in Chemical Engineering in 1982, 1986 and 1995.

Professor Dr. Pattarapan Prassassarakich is an expert in the teaching of Chemical Engineering Thermodynamics and has authored a textbook on that subject which has been widely used by academics from various institutions and is often cited in subjects dealing with Chemical Engineering and other related fields.

In the research projects she has conducted Professor Dr. Pattarapan Prassassarakich's focus has been on polymers and fuel technology. One important research on polymers concerns the hydrogenation of natural rubber and the graft polymerization of natural rubber that could lead to the development of natural rubber products in the polymer industry in the future. In terms of her research on fuels are the study of biomass processing to liquid fuels and the production of biomass oil through Supercritical Liquefaction of biomasses such as sugarcane, corn and palm oil. Her continuous research on biofuels has led to other vital research such as biodiesel production by way of hydrogenation of raw palm oil and used vegetable oil and the desulpherization of diesel oil through the process of absorption. A total of 113 of her research works have been published in international journals with a widely accepted data base and a number of them have received financial support from such government organizations as the National Science and Technology Development Agency and the Royal Golden Jubilee Ph.D Fund of the National Research Council of Thailand which is a collaboration with Pennsylvania State University in the U.S.A., and the University of Waterloo in Canada (1997-2017). She has been instrumental in producing doctoral graduates in Chemical Technology who ultimately have become highly qualified personnel integral to the work of energy and materials development in Thailand.

Professor Dr. Pattarapan Prassassarakich has held such important administrative positions as Deputy Director of the Petroleum and Petrochemical College (1989-1993) and Head of the Department of Chemical Technology, Faculty of Science (altogether two terms 1996-2000 and 2004-2007). She is currently an adviser for the Association of Polymers of Thailand and has given advice that has served to benefit the development of rubber and polymer technology in Thailand's academic and industrial circles.

After retiring from government service, Professor Dr. Pattarapan Prassassarakich was appointed Honorary Professor of the PTT (Public Company) (2018-2019). She continues her work at the Department of Chemical Technology both in terms of teaching and research and has contributed more to the volume of academic works she has produced.

Professor Dr. Pattarapan Prassassarakich is a scholar who is endowed with competence in academics, research and administration and has performed all tasks while displaying the virtues of great ethics and morality. She has achieved outstanding recognition at the national and international level. Chulalongkorn University Council has, thus, unanimously agreed to appoint her Professor Emeritus of the Faculty of Science to honour her in the years to come.

Her twenty pieces of work in the form of research, academic papers, books and textbooks present a body of knowledge that covers diverse issues and perspectives on Thai literature of the Sukhothai, Ayutthaya and Ratanakosin Periods, for example, the study of the literary conventions of the early Ayutthaya Period, the works of Sunthorn Phu, Thai prosody, vocabulary and expressions in Thai literature, the relationship between Thai and foreign literature and the relationship between Thai literature and contemporary literary works. She has written a number of manuals for several Thai literary works. These manuals, which have become sources for the study of Thai literature at the university level, are *Critical Reading and Interpretation of the Ong Kan Chaeng Nam, Critical Reading and Interpretation of the Maxims of Phra Ruang, Critical Reading and Interpretation of Nirat Narin* and *Critical Reading and Interpretation of Lilit Phra Lor.*

The academic and research works produced by Professor Dr. Chonlada Rueangraklikhit have been recognized in academic circles. of the Committee for the Promotion and Dissemination of the Thai Language, a member of the Committee for the Compilation of Foreign Vocabulary and Expressions Which Can Be Replaced by Their Thai Counterparts, a member of the Committee for the Committee for the Committee for the Committee for the Explanation of Thai Words for Radio Broadcast, an Ad Hoc specialist at the meetings of the Committee for Compiling Basic Vocabulary in Thai Culture, a judge for the Competition in Thai Language Skills and a judge for selecting distinguished users of the Thai language to be nominated for the Rajabundit Sansern Award. She also received a Joint Doctoral Research Intern Grant from the Culture Learning Institute of the East-West Center in the U.S.A. and completed her Doctoral Degree in 1983. In 1989, she became a lecturer in the Department of Philosophy at the Faculty of Arts and was appointed a full Professor in 2014.

Professor Dr. Suwanna Satha-anand has been distinguished in her teaching career serving as an advisor and a co-advisor to more than thirty graduate students. She has contributed to the development of her students turning them into knowledgeable and capable graduates in keeping with international standards. These graduates have later become high quality lecturers in Philosophy in Thailand's top academic institutions or have pursued their careers as researchers in Philosophy abroad.

In terms of academic matters and research, Professor Dr. Suwanna Satha-anand has produced approximately one hundred works in the form of books, research works, research papers, academic papers, translation works and book editorials. Some of her works that were written in English have been translated into French, Chinese and Korean. Her major research work deals with the translation of a collection of maxims in Confucian Philosophy, the *Lun Yü Doctrine*. She completed her studies for a Magister Artium (M.A.) and a Dr. Phil (Ph.D.—Doctor of Philosophy) from Ruprecht-Karls University in Heidelberg in the Federal Republic of Germany in 1980 and 1985 respectively. She started her teaching career in the German Section of the Department of Western Languages in the Faculty of Arts in 1976 and was appointed a full Professor in 2001. Her research works in the German language and literature as well as in German Studies are in the form of books, textbooks, translation works and articles; 164 in total. She has also served as the editor of eighteen books and journals.

As well as teaching students in the German Section of the Western Languages of the Faculty of Arts and in the Faculty of Applied and Fine Arts, the Faculty of Political Science and the Faculty of Science at Chulalongkorn University, Professor Dr. Pornsan Watanangura has been Chair of the Doctoral Degree Programme Drafting Committee of the German Section in the Faculty of Arts at Chulalongkorn University and also the Chair of the Working Committee of the Pedagogical Studies Programme, which is the only programme of its kind in Southeast Asia. From 2000 to 2012, she taught German to secondary school students at Klai Kang Won School as part of the Long Distance Learning via Satellite Project. > Honors Announcement Yaowalak Panyasing, DVM, Ph.D. A Recipient of the Distinguished Research Award, Faculty Member Category The Ratchadapisek Sompote Fund, 2019

Yaowalak Panyasing received a Doctorate in Veterinary Microbiology and Preventive Medicine from Iowa State University in the U.S.A., in 2013. At present, she is a permanent lecturer in the Department of Pathology of the Faculty of Veterinary Science at Chulalongkorn University.

Her distinguished, award winning research, "Working toward a CSFV Oral Fluid Antibody ELISA: Defining Oral Fluid Antibody (IgA, IgG) Kinetics against Envelope Glycoproteins (E2, Erns)" is a study of the existence of an oral fluid antibody (IgA and IgG) against Glycoproteins (E2 and Erns) of classical swine fever virus in the sampling oral fluid which responds to infection and vaccine production, together with developing the ELISA test set which has testing specifications for diagnosing and screening swine fever virus in each swine and in each pigsty. The research results are distinguished for the following reasons.

1. This is a new development in the diagnosing method of swine diseases, using oral fluid samples instead of a blood test.

2. This is the first research work to study the existence of antibody (IgA and IgG) in the sampling oral fluid of swine that are infected by classical swine fever virus and swine that have been vaccinated.

3. The results of this research have been developed into 4 test sets which have been submitted for patent registration, namely;

a. An invention, "A Test Set for Immunity against E2 Protein of Classical Swine Fever Virus from Oral Fluid Specimen," Patent Application Number 170300266.

b. An invention, "A Test Set for Immunity against Erns Protein of Classical Swine Fever Virus from Oral Fluid Specimen," Patent Application Number 170300127.

c. An invention, "A Test Set for Immunity against E2 Protein of Classical Swine Fever Virus from Sampling Water That Is Rinsed through Swine Meat or Serum Specimen," Patent Application Number 170300128.

d. An Invention, "A Test Set for Immunity against Erns Protein of Classical Swine Fever Virus from Sampling Water That Is Rinsed through Swine Meat or Serum Specimen," Patent Application Number 17030029.

4. This research was published in an international journal under the title, "Panyasing, Y., Thanawongnuwech, R., Ji, J., Gimenez-Lirola, L., Zimmerman, J. Detection of classical swine flu virus (CSFV) E2 and Erns antibody (IgG, IgA) in oral fluid specimens from inoculated (ALD strain) or vaccinated (LOM strain) pigs. Vet Microbiol. 208, 224: 70-77".

5. The test sets developed from this research have been further studied at Kansas State University for their efficiency in diagnosing classical swine flu virus and the study was published in an international journal under the title, "Popescu, L.N., Panyasing, Y., Gimenez-Lirola, L., Zimmerman, J., Rowland. R.R.R. E2 isotype-specific antibody responses in serum and oral fluid after infection with classical swine fever virus (CSFV). Vet Microbiol. 209, 235: 265-269".

> Honors Announcement Associate Professor Kunlaya Somboonwiwat, Ph.D. A Recipient of the Distinguished Research Award, Faculty Member Category The Ratchadapisek Sompote Fund, 2019

Kunlaya Somboonwiwat obtained a Doctorate in Biochemistry from Chulalongkorn University in 2015. At present, she is Associate Professor in the Department of Biochemistry of the Faculty of Science at Chulalongkorn University.

Her distinguished, award winning research, "Protein and Regulatory MicroRNAs in Shrimp Immunity against Severe Pathogens" is an in-depth fundamental research focusing on the search for and the study of the functions of genes, proteins and microRNAs in shrimp immunity, which is important in the resistance to bacteria and viruses that cause severe pathogens in shrimp. The research is distinguished in three aspects:

1. It has been accepted in the international academic circle, with 10 papers being published in international journals at the Q1 and Tier1 level.

2. The knowledge of shrimp immunity can be used to create an assessing process of shrimp health for research and development of products for boosting shrimp immunity.

3. This should contribute to producing a product prototype in the form of a shrimp supplementary nutrient which is efficient in reducing the occurrence of contracting bacterial and viral pathogens in shrimp.

> Honors Announcement Assistant Professor Thanapan Laiprakobsup Ph.D. A Recipient of the Distinguished Research Award, Faculty Member Category The Ratchadapisek Sompote Fund, 2019

Thanapan Laiprakobsup received a Doctorate in Political Science from the University of Houston in the U.S.A., in 2010. At present, she is Assistant Professor in the Department of Government of the Faculty of Political Science at Chulalongkorn University.

Her distinguished, award winning research, "Policy Network Advocacy in Rural Thailand: Case Studies of Agricultural and Community Welfare Policies" aims to analyze causal factors which lead to policy network advocacy in rural Thailand, explain the strategies for advocating such networks and systematically enforcing the policy-oriented agenda of a group and explain the relationship between the public policy process and the group as well as the network through the policy-oriented movement network at the grass roots level in rural Thailand. This research has found that groups and networks in rural Thailand vary in structure and their process of identifying the policy-oriented agenda. The factors that are influential on the structure, process and strategies are resources, knowledge, negotiation and the connection with external networks. The implications of this research are concerned with establishing a policy which takes the diversity of networks into consideration, encouraging participation in the process of policy establishing and developing democratic society by promoting policy-oriented groups and networks in rural areas.

This research consists of three main implications, namely;

1. In establishing the government's policy, it is necessary to take the diversity of the groups and networks in rural Thailand into consideration and to seriously give importance to the "participation" of people in the area where the policy is established.

2. The participation in the process of establishing a public policy for the evelopment of the groups and networks in rural Thailand includes offering all sectors—whether they are the people sector, civil society, the private sector or the government sector, — the ability equally to take part.

3. The promotion and development of democratic society should be aware of and accept "the diversity in the movements to enforce the policy-oriented agenda of the groups and networks in rural Thailand, which leads to people's trust in the process of establishing a public policy under the democratic system."

> Honors Announcement Associate Professor Puangthong Pwakapan, Ph.D. A Recipient of the Distinguished Research Award, Faculty Member Category The Ratchadapisek Sompote Fund, 2019

Puangthong Pwakapan received a Doctorate in History from the University of Wollonggong in the Commonwealth of Australia in 1995. At present, she is Associate Professor in the Department of International Relations of the Faculty of Political Science at Chulalongkorn University.

Her distinguished, award winning research, "Thai Foreign Relations in the Cold War Era," focuses on the international relations between Thailand and her Southeast Asian neighbouring countries, particularly Laos, Cambodia and Vietnam. This research is commended for the following aspects:

1. The research uses different periods during the Cold War Era as the focal points to explain Thailand's foreign policy. Though the War Era encompassed only five decades (the mid 1940s – the early 1990s), two major wars broke out in this region—the Vietnam War and a war in Cambodia. This was a time when the role of Thailand was important to the conflict and to the balance of power of the Super Powers in Southeast Asia. Thai foreign affairs during this time also affected the relationship with her neighbouring countries during the post Cold War Period.

2. Thailand's foreign policy during the Cold War Era also affected the national construction movement of Thailand, in terms of political, economic and social development. The results of this development have remained to be seen to the present.

3. This research explains the factors that assign the roles, policies and strategies of Thailand, specify national profit and the threat perception of the Thai government during each period as well as the role of each power group and each social power.

> Honors Announcement Associate Professor Sasi Pongsarayuth, Ph.D. A Recipient of the Distinguished Research Award, Faculty Member Category The Ratchadapisek Sompote Fund, 2019

Sasi Pongsarayuth received a Doctorate in Fine Arts from Chulalongkorn University in 2014. At present, she is Associate Professor in the Western Music Section of the Department of Music, Chulalongkorn University.

Her distinguished, award winning research, "The Innovative Musical Notation of Pali Sound from the Phonetic Tipitaka (Saj-Jha-Ya Tipitaka)" is a study of the problems in Pali pronunciation which does not correspond with the Kac-Ca-Ya-Na grammatical rules due to sound intervention from a mixture of the dialect, making Pali pronunciations which strictly follow grammatical rules deviate from the rules. The use of Western musical methodology, which is the international standard note notation method, is therefore a way of solving the problems coming from writing Pali sounds through the linguistic approach. This is because reading the scripts alone has a limitation in the shortage and the length of the sounds, which cannot be clearly specified as to how the sounds should be accurately pronounced. However, Western musical notes can be used as a tool to fulfill this lost dimension. The Western musical note notation is not complicated but it is able to efficiently contain the sound details and it has an accurate structure, using symbols that can be easily noticed and remembered. This research is distinguished in its ability to record 40 Volumes of the Tipitaka Scripture. The work is an integration of different disciplines; namely, musicology, linguistics, the Pali language, Buddhism and artistic design, being blended in harmony. This creation is not only a change in presenting the writing of sounds but it also opens up a new dimension of the Pali sounds, which are complex, making them easier to study. It unlocks the door of the cabinet containing the Tipitaka Doctrine which is inscribed on to palm leaves to connect the Buddhist Scripture with the digital world nowadays in a harmonious way. It is a way of disseminating the Saj-Jha-Ya Tipitaka to the international world through the Pali note notation method. This can be considered as the first time in the world that the Tipitaka Scripture has been recorded in Western musical notes. It is a continuation, extension and preservation of the Tipitaka in a new way for the benefit of the country and the human race.

> Honors Announcement Songsak Madsalae Ph.D. A Recipient of the Distinguished Research Award, Faculty Member Category The Ratchadapisek Sompote Fund, 2019

Songsak Madsalae received a Doctorate in the Arabic Language and Linguistics in 2013. He is now a permanent lecturer in the Arabic Language Section in the Department of Eastern Languages of the Faculty of Arts at Chulalongkorn University.

His distinguished, award winning research, "The Development of Roman Alphabets for Enhancing Arabic Pronunciation Skills of Thai Students" is the study and development of the Romanization of Arabic for the teaching and learning of the Arabic language. The researcher studied information from documents together with information from questionnaires in order to create a new system of Romanized alphabets, tested the efficiency of the Romanized alphabets to be used to replace Arabic sounds, developed and improved the Romanized alphabets and their use until he could obtain a new system of the Romanized alphabets, which was tested in the teaching of the Arabic language at the beginners level. The result was that the Romanized Arabic alphabets could help learners to pronounce Arabic words correctly and quickly. The research is distinguished for the following reasons.

This research is a study in linguistics, the Arabic language and education, characterized as research and development which has been continued with action research in the form of classroom research. The research methodology is both qualitative and quantitative, with different stages of study, test, inspection and certification until a body of knowledge leading to teaching and learning innovation is obtained. This set of Romanized Arabic alphabets is good to be used in accompaniment with Arabic language books for beginners and textbooks. At present, it is used for Arabic pronunciation in the teaching materials for Chulalongkorn University's students and outsiders. It is used in the online programme—CHULA MOOC and also by other academic institutions that offer classes in the Arabic language. The Romanized Arabic alphabet set has been well received and has helped to facilitate the teaching and learning of the Arabic language. Its use is not limited to Thai students only but it can also be used by foreigners because it is simple and the spellings are close to those of English, which is an international language. It has proved to be helpful in improving the efficiency of learning the Arabic language, leading the teaching and learning of the Arabic language into the new century. For this reason, the researcher has named it "Chula 100" to honour Chulalongkorn University on the occasion of its centenary.

> Commendation on the Occasion for outstanding research works in the Ratchadapisaek Sompote (King's Jubilee) Fund

> Honors Announcement Julaluk Noiphung, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Julaluk Noiphung received a Doctorate in Clinical Biochemistry and Molecular Medicine from the Faculty of Allied Health Sciences at Chulalongkorn University in 2018. At present, she works as a post-doctoral researcher of the Ratchadapisek Sompote Fund in the Graduate School of Chulalongkorn University.

Her dissertation, "Development of Simple Devices for Point-of-Care Screening of Bacterial Infection and Inflammatory Markers" has Assistant Professor Wanida Laiwattanapaisal, Ph.D., as the main advisor and Professor Charles S. Henry, Ph.D., as co-advisor. This work is a development of the paper-based analytical device for screening bacterial infections of the urinary system. The device developed is for examining the amount of nitrite and cultivating and screening the Escherichia coli bacteria from other kinds of bacteria that can be detected in urine. All this can be done using only one device. In the second part of the research, the researcher has developed a paper-based analytical device for measuring the Esteres enzyme in white blood cells by measuring the diameter of the existing reactions and using the result to compute the intensity of the enzyme found in urine. The two devices will be useful for screening urinary tract infections, particularly in homes for the elderly or in remote rural areas. The third part of the research is the development of a paper-based analytical device that helps to reduce the effects of viscosity, which differ in human saliva, and it is used to measure the PS value and nitrite in the saliva. The study has found that the difference in the viscosity of saliva significantly affects the creation of a standard graph for examining nitrite, and the buffer appropriately mixed to rinse the nitrite will nicely reduce such effect. The use of the devices developed for examining the saliva can help to screen oral infections and abnormalities. The aforementioned research emphasizes the application of the paper-based analytical devices for identifying biochemical substances and pathogens in the mucus of a human body, for example, saliva and urine. The use of such samples can lessen the need for a blood test. These devices are also very useful in developing countries as they can be used in field work, their test results can be reported guickly, their production cost is low and the production materials do not cause much environmental pollution. They have the chance to develop and be produced and used for commercial purposes.

Anchalee Prsansuklb received a Doctorate in Clinical Biochemistry and Molecular Medicine from the Department of Clinical Chemistry in the Faculty of Allied Health Sciences at Chulalongkorn University in 2019. At present, she is a permanent lecturer in the College of Public Health Sciences at Chulalongkorn University.

Her dissertation, "Mechanisms of Thai Medicinal Plant Extracts on the Attenuation of Glutamate Medicated Neurotoxicity" has Assistant Professor Tewin Tencomnao, Ph. D., of the Department of Clinical Chemistry in the Faculty of Allied Health Sciences at Chulalongkorn University as the main dissertation advisor and Associate Professor Alison T. Ung, Ph. D., of the Faculty of Science, Sydney Technology University in the Commonwealth of Australia as co-advisor. This research is a study of the competency of Thai medicinal plants in preventing or curing neurodegenerative syndromes, for example, Alzheimer's disease, testing whether Thai medicinal plant extracts can attenuate glutamate medicated neurotoxicity and what their attenuating mechanisms are. Glutamate toxicity is a significant mechanism which leads to the death of neuro-cells. The experiment found that, in comparison with other medicinal plants used in this experiment, ethanol extract from Acanthus ebracteatus leaves and that from Streblus asper leaves are able to prevent the death of neuro-cells from the toxic glutamate. Both extracts are able to protect the neuro-cells through the mechanism that reduces oxidants in cells and increases the activity of anti-oxidant genes at the RNA, the apoptosis method, which is introduced by the apoptosis AIF stimulant. In addition, the extract from Streblus asper leaves is ageing resistant as it is able to increase the life expectancy of C. elegans parasites. Therefore, Acanthus ebracteatus leaves and Streblus asper leaves are important natural sources, which can be developed into alternative medicine for the treatment of neurodegenerative syndromes in the future. The body of knowledge gained from this research is academically beneficial and it can be further studied and be used for commercial purposes as it can add value to Thai medicinal plants.

> Honors Announcement Panupong Mahalapbutr, Ph. D. A Recipient of the Distinguished Research Award, Ph. D. Student Category The Ratchdapisek Sompote Fund, 2019

Panupong Mahalapbutr received a Doctorate in Chemical Biology and Molecular Biology from the Faculty of Science at Chulalongkorn University in 2018. At present, he is a post-doctoral researcher in the Department of Chemical Biology in the Faculty of Science at Chulalongkorn University.

His dissertation, "Anticancer Activity of Mansonome G Derivatives against Human Non-Small Cell Lung Cancer: Computational and Mechanistic Study" has Assistant Professor Thanyada Rungrotmongkol, Ph. D., as the main dissertation advisor and Assistant Professor Piyanut Wonganan, Ph.D., as co-advisor. This research is a theoretical and experimental study of Mansonome G (MG) and derivatives against the signaling pathway which is controlled by the epidermal growth factor receptor protein (EGFR) in human non-small lung cancer cells of both the wild-type EGFR (A549) and the mutant-type EGFR (H1975) through the use of advanced scientific equipment. This has led to the discovery of highly competent MG (MG3) which exhibits toxicity against lung cancer cells of 4-9 times more than chemotherapy treatment (cisplatin) which is used now and it less toxic against normal cells. Moreover, the researcher has applied the existing technique of a complex inclusion substance and beta-cyclodextrin to increase, with significant implications, MG's ability to be dissolved in water, its stability and its anticancer activity. The body of knowledge obtained from this research is valuable in that it can be further used to develop MG 3 as a cancer treatment medicine which is more effective than the medicine currently used and/or it can be used as a prototypal structure in designing new anticancer medicine, depending on the information on atomic- level structure obtained from chemical-computer computation. This is a way of adding value to natural substances found in Thailand. In addition, the development of MG 3's ability to be dissolved in water through the existence of complex inclusion substance and beta-cyclodextrin to increase the efficiency in cancer treatment can be truly applied in the pharmaceutical aspect.

> Honors Announcement Wisarut Junprung, Ph. D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Wisarut Junprung received a Doctorate from the double degree programme in Biochemistry and Molecular Biology at the Faculty of Science at Chulalongkorn University and in Applied Biological Science (Aquaculture) from the Department of Animal Science and Aquatic Ecology from the Faculty of Bioscience Engineering at Ghent University in the Kingdom of Belgium in 2019. At present, he is a post-doctoral researcher in the Center of Excellence in Molecular Biology and Genomics of Shrimp in the Department of Chemical Biology at the Faculty of Science, Chulalongkorn University.

The dissertation, "Functional Characterization of Heat Shock Proteins during Stress Response in Pacific White Shrimp Penaeus vannmei and Brine Shrimp Artemia franciscana" has Professor Anchalee Tassanakajon, Ph. D., and Professor Peter Boucier, Ph.D., as the main advisors and Professor Gilbert Van Stappen, Ph.D., and Premruethai Supannakul, Ph.D., as the co-advisors. This research is a study of the characteristics and functions of heat shock proteins in response to stress, for example, heat and pathogens in two living creatures—white shrimp and Artemia shrimp. It has been found that heat stimulation and heat shock proteins are able to help white shrimp and Artemia shrimp to tolerate the heat and pathogen infection. The research has found that heat stimulation in shrimp enables the shrimp to tolerate the infection of Vibrio parahaemolyticus bacteria—the species which produces toxic proteins which are pathogens, causing a decrease in shrimp production. The discovered heat stimulation can be applied to the development of shrimp species to make them strong and tolerant to pathogens, as well as being applied for preparation in making young shrimp strong by nurturing them with heat stimulation before they are moved to be nurtured in an earthen pond. Moreover, the research has also found the difference of the one-position sequential new cleotide in Artemia shrimp which are tolerant to heat and bacterial infection. The difference found can be applied to tracking shrimp species that are tolerant and intolerant to pathogens through the use of a DNA marker. The stages in finding the DNA marker in Armetia can be used for DNA markers in other kinds of living creatures, for example, shrimp, an economically important creature of Thailand.

> Honors Announcement Sakda Jampasa, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Sakda Jampasa received a Doctorate in Science (Petro Chemistry) from the Faculty of Science at Chulalongkorn University in 2017. At present, he is a post-doctoral researcher at the Institute of Biotechnology and Genetic Engineering.

His dissertation, "Electrochemical Chemical Sensors for Human Papillomavirus DNA, C-Reactive Protein and Food Colorants Detections" has Professor Orawan Chailapakul, Ph. D., as the main dissertation advisor and Professor Therayuth Wilaiwan, Ph. D., and Associate Professor Weena Siengproh, Ph.D., as the co-advisors. This research is the development of electrochemical sensors for detecting medical biomolecular and food markers, using electric conductive materials and new research methods to create electrochemical sensor innovation to detect medical bio-medical markers. These consist of a sensor for detecting the DNA of high risk HPV viruses, types 6 and 18, and an electrochemical immuno-sensor for detecting C-reactive protein, which are markers of the risk of cervical cancer and cardiovascular diseases respectively. The sensor for detecting the DNA of HPV viruses is the first time that a synthetic biological probe has been applied, together with electrochemical detection, making this developed sensor precise and highly sensitive for detection. As for the electrochemical immuno-sensor for detecting C-reactive protein, the electrochemical pursuer which has been applied to this research is a new kind of electrochemical pursuer which yields high detecting signals and can easily be labeled on to an antibody. In detecting synthetic food colorants to control the quality of food and refreshments, this research has modified the surface of the electrode with graphite oxide in order to increase the precision range of detection. The research has found that an electrode whose surface is modified by graphite can yield higher responsive signals in comparison with an electrode which has not been modified. All this research work has created a new body of knowledge which can be further studied to yield benefits in a larger circle, especially in medicine and food, so that control, inspection and protection from diseases can be promptly executed. This body of knowledge can be used to develop a prototype for detecting pharmaceutical and environmental substances and others.

> Honors Announcement Sukanya Boonsri, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Sukanya Boonsri received a Ph. D. in Educational Measurement and Evaluation from the Faculty of Education at Chulalongkorn University in2019. At present, she is a lecturer in the Educational Research and Evaluation Section in the Department of Education at the Faculty of Industrial Education at the Thanyaburi Rajamangala University of Technology.

Her dissertation, "Development of Multi-Stage Computerized Adaptive Testing for Measuring Multidimensional Knowledge Competency of Vocational Technical Teachers" has Associate Professor Kamonwan Tangdhanakanond, Ph.D., as the main dissertation advisor and Professor Sirichai Kanchanawasi, Ph.D., as co-advisor. This research is a study to develop a competency model of vocational technical teachers, examinations and examination bank for measuring knowledge competency of vocational technical teachers as well as to develop multi-stage computerized adaptive testing for measuring the knowledge competency of vocational technical teachers of fourth- year undergraduate students in Industrial Education, which is a measurement of knowledge in the teaching profession and in industrial vocation for summative evaluation before these students go out to practice their teaching profession and for evaluation of the fifth-year students before they graduate. This is also a way of revising the program—how far the students are knowledgeable according to what the program requires, whether the instructional process of the program achieves what has been stated in the program and whether the result of this study will yield a program of multi-stage computerized adaptive testing for measuring multidimensional knowledge competency of vocational technical teachers. The students can use the evaluation result as information about which level of knowledge competency of vocational technical teachers they are at and what dimension of competency they should develop. The development of this testing also helps the process of measuring multidimensional knowledge of vocational technical teachers to be more efficient than traditional testing or one dimensional testing, which use less test time and fewer exam questions, in terms of accuracy, punctuality and precision in estimating the actual abilities of the test takers. Computerized adaptive testing can be carried out anywhere and at any time desired. The body of knowledge obtained from this research can be applied to yield more benefit in a larger circle or it can become a prototype for the development of a model for measuring more specific multidimensional knowledge competency of vocational technical teachers by focusing on teachers in specific vocations, for example, mechanics teachers, electrician teachers, electronics teachers, computer teachers, industrial work teachers and construction work teachers. This is in line with the demands of fields that are highly specific. It will also be a guideline for the development of multi-stage computerized adaptive testing for measuring knowledge competency of other vocations taught by other Faculties, for example, Engineering, Fine Arts and Agriculture.

> Honors Announcement Parinya Siriattakul, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Parinya Siriattakul received a Doctorate in Psychology (Development Psychology) from the Faculty of Psychology at Chulalongkorn University in 2019. Currently, he serves as the Director of the Academic and Research Counseling Center of the Political Science Association at Kasetsart University.

His dissertation, "A Development of the Casual Relationship Model of Social Skills in Deaf Children with the Theory of Mind as a Mediator," has Assistant Professor Panrapee Suttiwan, Ph.D., as the main dissertation advisor and Ajarn Nipat Pichayayothin, P.D., as co-advisor. This work has compiled information obtained from a total of 200 deaf children who are able to hear sounds at a sound level of above 90 decibels and are studying in Pathomsuksa 3 -6 in seven schools for the deaf. The hypothesis is that the deaf children's ability to understand other people's thoughts is at variance with their social skills. People's ability to understand other people's thoughts is involved with the perception of the thoughts, feelings, emotions and beliefs of others as they really are but, for deaf children, it is found that their ability to develop an understanding of other people's thoughts is slower than that of children in general, resulting in their inability to understand actions, emotions and thoughts in the same way as other people's perception. This causes them problems in emotional and social adjustment; for example, aggressive behavior seen in their destroying things or hurting others, socio-psychological problems, depression, problems in emotional control and problems in interacting with others. All these problems reflect the slowly developed social skills of deaf children. This research is therefore the starting point for comprehending the ability to understand other people's thoughts. If deaf children's ability to understand other people's thoughts is developed in accordance with their age, they will be able to understand others according to the reality perceived by others, adjust themselves to get along with other children and society, possess social skills and lessen their problematic behavior.

> Honors Announcement Saengsom Kor-udem, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Fund, 2019

Saengsom Kor-udom received a Doctorate in Criminology and Justice from the Faculty of Political Science at Chulalongkorn University in 2019. At present he is an official in the position of Policy and Implementation Plan analyst at the Rapeepatanasak Research and Development Institute, the Office of the Judiciary.

Her dissertation, "From the Perspective of the 'Russian Mafia': An Analysis of Transnational Organized Crime in the Thai Social Context" has Assistant Professor Sumontip Chitsawang, Ph.D., as the main dissertation advisor. The work is a study of the behavior and types of crimes committed by the Russian Mafia in Thailand, their motivation, attitudes and perspectives towards the Thai social context, which affect their decision to commit crimes in Thailand. The research methodology involved collecting information from in-depth interviews of personnel in the judicial procedure; namely, police officers, immigration police and international police, as well as Russian inmates. A sample group of Russian inmates was interviewed, using Russian in the communication between the researcher and the inmates. The sampling group was also screened by a member of the Russian Mafia Transnational Organized Crime, using official documents to accompany the analysis and to synthesize the information. The knowledge from this research is valuable for developing a criminological theory in a new dimension, which is no longer limited to motivating causes, criminal behavior and types of crimes to explain the phenomena or the causes of crimes but also lends importance to and promotes an awareness of other factors, for example, perception of the attitudes and dimensions of the Russian Mafia in the Thai social context, which are important factors in analyzing and synthesizing the decision process in committing crimes. Policy and practical suggestions obtained from this research can be developed into guidelines or practical ways of dealing with the solutions to problems arising from the crimes committed by the members of the Transnational Organized Crime Group in a concrete way for working groups in the judicial sector.

> Honors Announcement Thidarat Tannirat, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Category The Ratchadapisek Sompote Fund, 2019

Thidarat Tannirat received a Doctorate in Educational Technology and Communication from the Faculty of Education at Chulalongkorn University in 2018. At present, she is a lecturer and Assistant to the Dean of the Faculty of Education at the Bansomdejchaophraya Rajabhat University.

Her dissertation, "Development of an Instructional Model by Integrating Information Problem Solving, Scaffolding and Z to A Approach for Creative Product Development" has Associate Professor Nawanit Songkram, Ph.D., as the main advisor and Associate Professor Chaitip Na Songkhla, Ph.D., as co-advisor. The work is research into and the development of an instructional model by integrating information problem solving, scaffolding and a Z to A approach for creative product development. This instructional model is a mixed type of online instruction and in-class instruction, consisting of six components as follows: 1) learning contents; 2) instructional strategies; 3) the role of teachers; 4) the characteristics of students; 5) instructional media; and 6) assessment. Learning consists of six stages; namely, 1) introduction and providing knowledge, 2) identifying problems through the use of IT, 3) searching for information, 4) scanning the information, 5) applying the information to developing creative products, and 6) drafting and filing an application for a patent. When this instructional model was tested with the students, it was found that 84.62% of them, at the highest level, were able to develop creative products and apply them for a patent, and this complied with the research hypothesis. In considering the assessment results and the certification of the instructional form by specialists, it was found that they were at an average of 4.80, being at the most appropriate level. Therefore, the form of instructional model obtained from this research is valuable and should be able to be used or applied to creating benefits in educational circles. It can train students to develop creative products, make them learn how to think and solve problems that occur while developing the work under the supervision of the teachers. This is a way of strengthening their experience before they enter the professional world.

> Honors Announcement Waraporn Cherdchoo, Ph.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Waraporn Cherdchoo received a Doctorate in Fine Arts from the Faculty of Fine and Applied Arts at Chulalongkorn University in 2018. At present, she is a permanent lecturer in the Thai Musicology Section at the Department of Music in the Faculty of Humanities, Naresuan University.

Her dissertation, "A Musical Suite: Phin-Dukkhanirodhagamminipatipada" has Associate Professor Kumkom Pornprasit, Ph.D., as the main dissertation advisor and Associate Professor Pakorn Rodchangphuen as co-advisor. The dissertation is a creative research derived from the study of the phin (a lute-like musical instrument) music according to the Buddhist concept taken from ancient documents of the Indian and the Thai civilization. The study of the musical instrument of the phin family in Indian culture is divided into three main periods—the first period being the ancient period to the Veda period, the second period being the post Veda period and the third period being the Middle period. This study explains the connections between the musical instruments of the phin family, which existed at a time when Buddhism prospered. This has never been studied before. The research also explains the relationship and the characteristics of the phin in the two cultures as well as information about the music played by the *phin* that occurs in the Tipitaka Scripture, which consists of the Tipitaka in Pali written in the Thai alphabet and the Thai version of the Tipitaka. The information about the music played by the *phin* can be presented in three parts—philosophical information, religious information and musical information. These three parts explain the connection between the phin musical phenomenon and the Middle Path in the religious principle as well as the evident conclusion of the *phin* musical instruments which appear in the Tipitaka. This has been understood as belief or referred to as precept; however, facts have led to the conclusion that the phin had a real physical existence and it may be possible to specify the time of their existence which goes back to not later than the fourth century of the ancient Indian culture and has a connection with the krachub-pi or the four-stringed lute in the ancient Thai royal court. There were also other musical instruments of the same shape in Southeast Asia. This research has been developed into musical creativity, being the first Thai musical composition that describes the Dhamma about the Middle Path through musical rhythms and lyrics created from a combination of a new creative style and the traditional composition style. This has led to the discovery of particular characteristics of sounds, a series of melodies and a principle in creating musical aesthetics which is related to the essence of the Dhamma in a unified manner. The research has raised the perspective and a frontier that connects music with Buddhism, resulting in in-depth information which should contribute to Buddhist Studies. The research may also develop knowledge in the composition of Thai music to produce a new body of knowledge that can become a prototype or guidelines in creating Thai music, which can be applied in order to bring greater benefit to academic circles and Thai society at large.

> Honors Announcement Pasu Roungpanyaroj, P.D. A Recipient of the Distinguished Research Award, Ph.D. Student Category The Ratchadapisek Sompote Fund, 2019

Pasu Roungpanyaroj received a Doctorate from the Faculty of Fine and Applied Arts at Chulalongkorn University in 2019. At present, he is the owner of kinetic jewelry of the brand, PASU IT"S ALIVE.

His dissertation, "Innovative Kinetic Jewelry Design from Thai Cultural Capital" has Associate Professor Patcha Utiswannakul, Ph.D., as the main dissertation advisor. The work is a study and compilation of the information on the concept of Thai cultural capital and that of kinetic art, which has been researched and developed into contemporary jewelry to provide something unique to the market. This is also one step further in developing and creating design work that uses Thai cultural capital. The research has found that creating jewelry design from Thai cultural capital of the Thai puppet type has resulted in jewelry that can use the identity of Thai puppets in terms of structure, internal kinetic mechanism and external appearance and combine them with the kinetic concept to create innovative jewelry design which is unique in a commercial respect. A new method of jewelry design has been found; the jewels can be moved or disassembled in order to change their function on different occasions according to the wearer's wish.

The creation of kinetic innovative jewelry from the concept of Thai cultural capital is a way of making the new generation realize the significance of Thai culture, which is unique in the world, to encourage them to turn to designing contemporary jewelry that is based on Thai cultural capital. This coincides with the government's policy that wishes to develop and promote the commercial aspect of Thai cultural capital in order to create an opportunity to develop innovative jewelry design to ensure the sustainability of Thailand's commercial, social and cultural aspects.
